<p>Violation #16. Food-contact surfaces; cleaned & sanitized -Observed ice scoop on top of ice machine without proper storage. Clean and sanitize scoop to prevent contamination. Provide proper storage to ice scoop. Corrected action: Ice scoop was cleaned and sanitized, and was properly stored. COS</p> <p>CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.</p>
<p>Violation #36. Thermometers provided & accurate -Observed missing thermometer inside of refrigerator and freezer located inside of laundry room; inside of freezer #8 located in front of serving line #1; and inside of refrigerator located next to the dry storage/office room. Provide thermometer to correct reading. Corrected action: Thermometers were provided. COS</p> <p>CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #56. Ventilation & lighting -Observed light bulb burned-out inside of refrigerator and the two-freezer located in front of serving line #1; inside of freezer located in front of ice machine; and inside of refrigerator located next to the dry storage/office room. Replace light bulb to provide lightning.</p> <p>CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
